NAVIGATION INFORMATION AND COOKIES

This page describes how the site is managed with regard to the processing of personal data of users who consult it. The processing is always based on the principles of lawfulness and fairness in compliance with all current regulations and appropriate security measures are taken to protect the data.

This privacy policy is also given as a brief information pursuant to art.13 of the European Privacy Regulation 679/ 2016 (GDPR), art. 19 of the Federal Data Protection Act (LPD); in addition, pursuant to Cookie Provision No. 229 of 8 May 2014, we would like to inform visitors of the site about the use of data entered in and cookies used by the site itself.

Personal information that we collect.at the time of registering for the newsletter

Purposes of processing

We inform you that the data collected with the registration of your name or that we found through the consultation of public registers, lists or documents known by anyone, will be processed in compliance with the aforementioned provisions and the confidentiality obligations that inspire the activity of **NGI Trading SA**.

The processing carried out by **NGI Trading SA** will be based on the principles of fairness, lawfulness and transparency and protection of your privacy and your rights.

The data will be used for commercial, promotional, and advertising purposes, as well as for management and statistical purposes. We process your personal data lawfully, correctly and with the utmost confidentiality. They are recorded, organized, and stored in computer archives. The data may be communicated by us to our commercial network, to consultants in administrative/ commercial, to transporters for the delivery of goods/ illustrative material and to parent companies, and subsidiaries.

Additional purposes

The computer systems and software procedures responsible for the operation of this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of internet communication protocols. This information is not collected in order to be associated with identified data subjects, but by their very nature may, through processing and association with data held by third parties, allow users to be identified.

This category of data includes the IP addresses or domain names of the computers used by users connecting to the site, the addresses in URI (Uniform Resource Identifier) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numeric code indicating the status of the response given by the server (good end, error...) and other parameters related to the operating system and the computer environment of the user.

This data is used only for the purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and is deleted immediately after processing.

Identity of the Data Controller

This site is managed by the Data Controller, identified in the person of the owner and Sole Administrator of the company **NGI Trading SA**, Via delle Scuole, 3B 6900 Paradiso (Switzerland).

The Data Controller guarantees the security, confidentiality, and protection it possesses at any stage of the processing process.

The collected data are processed and used in compliance with current legislation on data protection (GDPR and LPD).

Place of Processing

The data will be processed by the data controller at its operational headquarters in Via delle Scuole, 3B 6900 Paradiso (Switzerland), and by the data processors appointed by him at his offices. The list of responsible persons is available at **NGI Trading SA**.

Refusal to Provide Your Data

You, as the data owner, may refuse to provide the Data Controller with your navigation data. To do this, you must disable cookies following the instructions provided by your browser. Disabling cookies can worsen the browsing experience and reduce the functionality of the site.

Recipients of Data

No data deriving from the web service (navigation data specified above and cookies) is communicated or disseminated (without prejudice to communication to judicial or police if necessary).

The data are processed by personnel specially appointed to process the data (administrative and public relations staff also external to the Company, information systems managers also external to the Company who can also perform functions of system administrator and are then appointed as such, marketing personnel also external to the Company, interns, data processors and their collaborators, in charge of the specific sector to which a request is addressed, site managers also external to the Company) only where the processing is necessary for the performance of their duties and only carrying out the operations necessary for the performance of those tasks.

They may also be processed by data processors (including companies outside the Company that carry out shipping, marketing, and server management and storage activities). Definition of cookies
